Children and women were provided a one year supply of vitamins and all in need were provided anti-parasite medication. Rural Health volunteers were trained in emergency services.

FOB's Extended Care Program provided care to more than 250 children with extensive medical needs. The program also provided medications, patient care plans, specialist visits, and surgeries for children in need.
